

Blaby Victoria Tennis Club - Court Booking System Terms and Conditions Of Use

The Blaby Victoria Tennis Club court booking system is provided as a benefit to members whilst the club maintains membership to ClubSpark.

1 COURT BOOKINGS

- 1.1 The Club is open for play in accordance with the hours displayed in the online court booking system. Bookings must be made online via members LTA/ClubSpark account at <https://clubspark.lta.org.uk/BlabyVictoriaTennisClub/Profile>
- 1.2 Court bookings should be made in the name of a player who will be on the court. Players may be asked to leave the court if the named person who made the booking is not present.
- 1.3 Court use is free of charge for paid members. Guests incur a fee and the person making the booking is responsible for ensuring any guests have paid the appropriate fee. Members are responsible for guests following terms and conditions and other club policies.
- 1.4 League matches take priority in court use and your booking may need to be postponed if there is a clash.
- 1.5 Parents as Main Contact for juniors make bookings for Junior play through the ClubSpark system on our website. Parents are responsible for supervision of their children and no-one under the age of 14 may play on the courts unsupervised.
- 1.6 The gate padlock code must not be shared with non-members.
- 1.7 On arrival at the court, at the start of your session, if necessary show your confirmation text message or email to anyone using the court and politely ask them to finish their session.
- 1.8 If you are playing on the court, please respect other players who have booked the court after you and move off the court at the end of your time slot. In the event that there are no bookings directly after yours, you may use the courts until the next booking arrives.
- 1.9 During periods of poor weather, players must decide themselves whether the courts are suitable for playing and do so at their own risk. Members and guests are expected to self reflect that they are in sufficiently good health to play.
- 1.10 The last person to vacate the courts is responsible for securing the padlock to the gate (including the far, south side, gate between Court 1 and Court 2 if it has been unlocked).

2 PAYMENT

- 2.1 Court use is free of charge for paid-up members.
- 2.2 Members will pay by on-line banking into the Club account on the day of the booking for any invited guests at the current annual rate with member name as reference. Current rate for invited guests is £5 per session. Sort code 56-00-55, Account number 11378751.
- 2.3 Full court hire is available at a different rate and terms on application to the Bookings Secretary.

3 CANCELLATION POLICY

- 3.1 If you need to cancel a court booking, please consider other members and endeavour to make the cancellation with 48 hours' notice prior to the court booking start time.
- 3.2 Cancellations must be made through the online booking system.

4 General

Members are reminded of the Terms & Conditions of membership to which they have already agreed to on membership of the club.
